- As per PPRA 2014 Rule 38(2) (a) single stage two envelopes bidding procedure, both tender (Technical + financial) should be submitted in separate envelopes marked as Technical and Financial. In the first instance, the “Technical Proposal” shall be opened and “Financial Proposal” will be opened only for the technically compliant bidders.
- The contract will be for the period of one year.
- Tenders received after the due date and time will not be brought under consideration.
- Copies of Income tax and Sales Tax Number should be furnished by the firm. Other required documents are specified in tender documents.
- Bid Security in form of CDR/Pay Order in Favor of **PAMCO** of Rs. 52,500/- of total estimated cost i.e. Rs: 5,250,000/-.
- The competent Authority may reject all the bids or proposal at any time prior to the acceptance of bid or proposal as per Rule 35 of PPRA-2014.
