- 2. Interested Parties should submit bid in single envelopes marked as Technical and Financial Proposal.
- 3. Frame work contract shall be for the period of **01** Year.
- 4. Tenders received after the due date and time shall not be brought under consideration.
- 5. Bidders are required to submit evidence of NTN & STRN/PRA registration number along with other required documents as stated in tender document.
- 6. Bidders are required to submit bid security in form of **2%** CDR/Pay Order/Demand Draft in Favor of "Punjab Agriculture & Meat Company" amounting to Rs. **92,000/-** of total estimated cost i.e. **Rs. 4,600,000/-**.
- 7. The financial bid shall be considered as inclusive of all taxes.
- 8. The Competent Authority may reject all the bids or proposal at any time prior to the acceptance of bid or proposal as per Rule 35 of PPRA-2014.
