FOR AUCTION OF UNSERVICEABLE/ UNUSABLE (SCRAP)

PAMCO intends to conduct an open auction, following Punjab Government Rules, for the disposal of various unserviceable and scrap items, including electrical equipment, mechanical equipment, furniture, IT equipment, tyers, etc.

Interested parties may visit PAMCO in person to inspect the type and condition of the scrap material between 9:00 AM and 5:00 PM, Monday through Friday during working hours and they must possess valid business registration and in case of individuals having CNIC cards. Furthermore, the interested parties must have an active tax status with the FBR for both income tax and sales tax.

Auction details:

- The reserve price for all auction items is Rs. 2.5 million, exclusive of all taxes.
- All government taxes, including but not limited to sales tax and income tax at the prevailing rates, will be the responsibility of the successful bidder and will be added on top of the winning bid amount.
- The date for the open auction of lots at PAMCO will be ______ 2024.
- The auction will be held in the presence of auctioneers and bidders.
- PAMCO reserves the right to accept or reject any or all bids following Punjab Government rules.
- The auction will be conducted on an "as is, where is" basis.
- All other terms and conditions will be available on PAMCO's website.
- All bidders must submit a refundable bid security deposit of Rs. 50,000/in the form of a bank draft, Cash Deposit Receipt (CDR), or cash, payable
 to "Punjab Agriculture & Meat Company."

TERMS AND CONDITIONS FOR AUCTION OF SCRAP/UNSERVICEBALE MATERIAL

- An affidavit on legal stamp paper (original) shall be furnished by the bidder that he is not blacklisted by any government department.
- ➤ The highest bidder will be declared successful after verification.
- ➤ If the highest bid is lower than the reserve price mentioned in the document, the auctioneer reserves the right to accept or reject the highest bid.
- ➤ The auctioneer shall hand over to the successful bidder without any further renovations and in the same condition as at the time of the bidding process.
- ➤ In case any asset is damaged during the work, the successful bidder will be responsible for making good the damage
- ➤ The successful bidder shall be bound to deposit the auction money in advance within three (03) working days after the acceptance letter is issued and in case of failure to deposit the advance money within the stipulated time, the bidder's security shall be forfeited. .
- ➤ All government taxes whether federal or provincial, duties, levies, at prevalent rates, shall be the responsibility of the successful bidder.
- ➤ The auctioneer may reject all proposals or cancel the bidding process at any stage before accepting any proposal or cancel all the bidding process at any stage.
- ➤ Before accepting any proposal, bid security of three lakhs of three highest bidders will be maintained and returned after completion of the successful bidder.
- ➤ Lifting of goods shall not be permitted during night hours or during public holidays otherwise the permission issued shall be canceled and the goods shall be reauctioned without any notice.
- If the successful bidder wishes to leave the business before the expiry of the contract period, then the amount paid in advance including the bid security shall be surrendered and the auctioneer shall not be entitled to any refund of any payment related to the contract.
- > The successful bidder will be responsible for picking up all goods within seven days
- The successful bidder shall not damage the surrounding greenery/vegetation
- The security deposit will be returned after the process is completed

- ➤ The Bidder shall not sublet the awarded contract in whole or in part to any other party or organization etc. on rent or commission.
- ➤ In case of any problem, the decision of Punjab Agriculture and Meat Company will be considered final
- ➤ All costs of handling the goods shall be borne by the successful bidder
- ➤ No labor, machinery, equipment, vehicles etc. will be provided by the company.
- ➤ The successful bidder will be responsible for the safety of the goods. And will be responsible for complying with the government rules for the protection of all types of goods including tools and equipment, valuables, life and property during the work in the company premises. The company will not be responsible for any damages.
- ➤ In case of any complaint or matter, the decision of CEO Pimco will be final. The Bidder shall not be entitled to challenge the final decision in any court or institution.
- ➤ Those who wish to participate in the bid can submit the application for inclusion in the bid along with the necessary documents and security as per the conditions of the bid letter to the office of the undersigned by three o'clock in the afternoon.
- ➤ Both the parties shall be bound to abide by the above conditions and the first party shall have the right to cancel the contract in case of violation of the above conditions.
- ➤ The auctioneer may terminate the bidding process at any time without assigning any reason.
