

AUCTION NOTICE

Outsourcing of Meat Processing (Boiling, Cooking, Preparing Jerky) Space

Punjab Agriculture and Meat Company (PAMCO), a government-owned, not-for-profit organization, is engaged, inter alia, in providing meat processing services and promoting integrated value chains for both domestic and export markets. PAMCO adheres strictly to national and international quality and compliance standards in the operation of its work.

Through this notice, PAMCO invites interested parties to participate in an **Open Auction**, in accordance with Punjab Government Rules, for the outsourcing of meat processing space on an “**As is, where is**” basis for a period of **one year**.

Site Inspection

1. Right of visit

All interested parties/bidders shall be permitted to visit and/or conduct a physical inspection of the aforementioned site, either personally or through a duly authorized representative(s), strictly between official working hours i.e. 9:00 AM and 5:00 PM, on Monday(s) and Tuesday(s) before the said auction.

2. Proof of authorization

All visiting parties and/or their representatives shall be required, as a precondition to their entry(ies), to carry and produce upon demand a valid and subsisting business registration certificate(s), together with written authorizations, where applicable, thereby evidencing their authority to act on behalf of the interested party/bidder.

3. Non-Tampering Obligation

Any person permitted to enter and/or inspect the site shall do so solely for the purposes of observation and assessment. Under no circumstances shall such person interfere with, alter, tamper with, modify, damage, or remove any property, fixtures, or equipment located on the premises. Any breach of this obligation shall constitute immediate grounds for disqualification and may further give rise to civil and/or criminal liability.

4. Liability Disclaimer

All visit(s) and/or inspection(s) shall be undertaken strictly at the risk and responsibility of the visiting party and/or its representatives. PAMCO, its employees, staff, and agents shall bear no liability whatsoever for any injury, loss, damage, or claim arising out of or in connection with the said visit or inspection, howsoever caused.

5. Regulation of Entry

PAMCO reserves the absolute right to regulate, restrict, or refuse entry to the site in the event of non-compliance with the foregoing requirements, along with misbehavior with PAMCO's management and/or staff, and its decision in this regard shall be final, conclusive and binding.

Eligibility Requirements

1. Tax Compliance

Each bidder must be in possession of an active National Tax Number (NTN) and valid General Sales Tax (GST) registration status(es) with the Federal Board of Revenue (FBR). Evidence of such compliance must be produced upon demand, and any bidder found to be non-compliant shall be deemed disqualified without further recourse. The decision of PAMCO to disqualify on such basis shall be final, conclusive and binding.

2. Industry Experience

Each bidder shall be required to demonstrate a proven, verifiable, and extensive background in the field(s) of meat processing. For purposes of this clause, PAMCO shall have the sole and unfettered authority/discretion to assess the sufficiency and relevance of such experience, and its determination shall be final, conclusive and binding.

3. Right of Verification

PAMCO reserves the absolute right to verify, inspect, and/or otherwise require evidence substantiating compliance with the foregoing eligibility requirements. Any misrepresentation, concealment, or submission of false/frivolous documents by the bidder shall constitute grounds for immediate disqualification, forfeiture of deposits, and exclusion from current and future auctions.

Terms of Participation

1. Security Deposit

Each bidder shall be required, as a condition precedent to participation, to deposit a sum of PKR 500,000/- (Rupees Five Hundred Thousand Only) as a refundable security deposit. The refundability of this deposit shall remain subject always to the bidder's full compliance with all terms and conditions governing the auction.

2. Registration Fee

Each bidder shall, in addition to the security deposit, pay a sum of PKR 15,000/- (Rupees Fifteen Thousand Only) as a non-refundable registration fee.

3. Mode of Payment

All payments under Clauses 1 and 2 herein, shall be made exclusively by way of Bank Draft(s), Cash Deposit Receipt(s) (CDR), or cash, in favour of the Punjab Agriculture & Meat Company ("PAMCO"). PAMCO shall have absolute discretion and authority to determine the validity/acceptability of the tendered payment instrument.

4. Taxes and Statutory Levies

All applicable taxes, duties, and levies, including, without any limitation, Income Tax and Sales Tax, shall be borne solely by the successful bidder and shall be charged strictly in addition to the final bid amount. PAMCO shall not be responsible, or liable in respect of tax obligations that may arise out of this procedure.

5. Final Authority

PAMCO reserves the absolute and unfettered right to enforce strict compliance with the foregoing participation terms, and its determination on any matter relating thereto shall be final, binding, and not subject to any form of challenge/review.
